Legislative Session Updates



Overview

• The 2023 legislation session has been one of the most transformative legislative sessions in state history. DEED staff worked diligently to advance several key initiatives to benefit Minnesota and several of those initiatives positively impact people with disabilities served by VRS. Historic investments were made increasing funding for programs that support Minnesotans with disabilities including increased funding for State Services for the Blind (SSB,) Individual Placement & Support Services (IPS) and the creation of a new Reasonable Accommodation Fund to name a few of the legislative advancements.



How does this impact funding for VRS programs?

• The Centers for Independent Living (CIL) received the largest increase in 30 years. For state fiscal years 24-25, the CILs will receive \$7,011,000 each year. The base for this appropriation is \$3,011,000 in state fiscal year 2026 and each year thereafter

• Individual Placement and Supports (IPS) provides critically needed, evidence-based supports to people living with serious mental illness. As a result of VRS and community advocates working diligently, IPS will receive \$2,555,000 million dollars each year for fiscal years 24 and 25 and an increase of \$2,500,000 million dollars per year for fiscal years 24 and 25.



How does this impact funding for VRS programs?

• Minnesota legislators also passed a bill that will positively impact Extended Employment Services (EE). The EE base will continue to be \$6,995,000 from the general fund and \$6,830,000 from the workforce development fund for fiscal years 24-25. In addition, \$4,500,000 has been appropriated from the general fund for each year to maintain prior rate increases for providers of extended employment services for persons with severe disabilities.

• For state fiscal years 24-25, \$1,000,000 was appropriated each year from the workforce development fund for employment services for persons, including transition age youth, who are deaf, deafblind, or hard of hearing.



Other Legislative Updates

- Minnesota legislators also passed a bill (*Chapter 63 H.F.100*) that will legalize the recreational use of Adult Cannabis. This means the use of Adult Cannabis will be legal in Minnesota but remains illegal at the Federal government level.
- This bill allows for expungement of past offenses, which will be impactful for jobseekers
- Vocational Rehabilitation Services receives substantial funding from the federal government. VRS can not support an employment placement or small business plan within the Adult Cannabis industry.
- DEED will have funding for three programs that provide financing for workforce development, small business loans, and technical assistance related to cannabis businesses and workforce CanStartup, CanNavigate and CanTrain.

Managing VRS and Community Partner budgets: VRS responsibilities

- It is imperative our agency does a good job of managing our open encumbrances. We never get billed for many authorizations that we write and these need to be canceled. This happens for a variety of reasons. Good communication between VR professionals, VR Support Staff, and the Community Partner is essential!
- It is our responsibility to spend some time monitoring expired authorizations (open encumbrances). If an authorization is not going to be used, the lines on the PO in SWIFT need to be cancelled and the amount will then be available for use by another participant
- Vocational Rehabilitation Techs and Support Staff should take the responsibility of monitoring the
 open encumbrances for their team. This means they need to review the 60-day report at least
 monthly, possibly have some investigative work done and reduce the amount on the PO or cancel
 the line(s) on a PO that will not be used.



Managing VRS and Community Partner budgets: CP responsibilities

- Invoice requirements are outlined in Section 5, Consideration and Payment, of this Master Contract or in the Community Partner Guide (mn.gov/deed/job-seekers/disabilities/partners/guide/contracted-services/billing).
- The following constitutes an "undisputed invoice" that is ready for payment.
 - The Contractor presents an itemized invoice for the services actually performed with required elements of the invoice as detailed in the Community Partner Guide (mn.gov/deed/jobseekers/disabilities/partners/guide/contracted-services);
 - The Contractor presents required documentation as detailed in the Community Partner Guide (<u>mn.gov/deed/job-seekers/disabilities/partners/guide/contracted-services</u>); and
 - The State's Authorized Direct Service Staff Representative accepts the services as satisfactory, the invoice as satisfactory, and the required documentation as satisfactory.



Managing VRS and Community Partner budgets:CP responsibilities

Invoices **must be** submitted **within 90 days** from the end date of the Work Authorization.

Invoices received after 90 days will not be paid.

Funding Notice

The VR program receives 78.7 percent of its funding through a grant from the U.S. Department of Education. For federal fiscal year 2022, the total amount of grant funds is \$44,081,347. The required state match for these funds is \$11,930,529 (21.3 percent). The state of Minnesota has appropriated \$14.3 million to exceed the matching requirement.
