Earned Safe and Sick Leave Time – VRS reimbursement process

- On January 1, 2024, the Department of Labor and Industry's (DOLI) Earned Sick and Safe Time (ESST) law went into effect for all Minnesota employers. Sick and safe time is paid leave employers must provide to employees in Minnesota.
- On January 22, 2024, Lori Thorpe, Director of Contracts and Partnerships, sent out an email with a recorded video which details the process of how Vocational Rehabilitation Services will reimburse those partners that have Wages on their contract.
- These changes only apply to our Community Partners who have Wages for Job-Related Services and Pre-ETS on their Professional/Technical Contract

Earned Sick and Safe Time, cont.

• In a nutshell, between January, 2024 and June 30, 2024, VRS will add one hour of wages for each 30 hours of wages on authorizations to cover the ESST requirement of our Community Partners.

 Beginning on contracts starting July 1, 2024, the Wages + 60% administrative cost will begin to be authorized. The additional percentage in administrative costs will cover the ESST requirement for our Community Partners.

July 1, 2024 Contracting Process and Timeline

All existing P/T contracts are due to expire on 6.30.2024.

There are different processes for a variety of our contracts to be renewed for 7.1.2024

Contracting, cont.

• Community Rehabilitation Partners' contracts are being amended to have a larger budget, negotiated fees for services, and a new end date of 6.30.2027. These amendments will have a start date of 7.1.2024.

• Limited Use Vendors that began a contract on 7.1.2022 will have an open Request for Proposal and will submit new applications for a contract to begin on 7.1.2024 and end on 6.30.2026.

Updates, cont.

Managing authorizations for budgets: Teamwork makes the Dream Work!

- It is vital to have accurate budgets for all LUV and CRP contracts.
- Accurate authorizing and budgets for Vocational Rehabilitation Services is essential for our fiscal management and financial forecasting.
- VRS staff have the primary responsibility to authorize and manage the open encumbrances (i.e. 30-60-90 day reports).
- Community Partner agencies can help manage the authorizations by requesting accurate hours for authorizations, billing in a timely fashion, and notifying the referring VRS staff when remaining hours can be cancelled.

Updates, cont.

We have a robust Community Partner pool!

- We currently have <u>178</u> Community Partners with active contracts! We are grateful for each of them and their dedication to providing quality services.
- The four Community Partnership Program Specialists are each meeting with several new applicants for contracts.

Several of our newer Community Partners have received no, or very few, referrals.



Funding Notice

The VR program receives 78.7 percent of its funding through a grant from the U.S. Department of Education. For federal fiscal year 2022, the total amount of grant funds is \$44,081,347. The required state match for these funds is \$11,930,529 (21.3) percent). The state of Minnesota has appropriated \$14.3 million to exceed the matching requirement.
