

Clean Water Revolving Fund 2024 Intended Use Plan

I. Introduction

The federal Clean Water Act authorizes the Clean Water State Revolving Fund (CWSRF) program to provide funds to states to finance water pollution control projects. Under the Act, the U.S. Environmental Protection Agency awards annual capitalization grants to each state to capitalize a state revolving fund, which the state can then use to provide financing for point source (wastewater and stormwater) and nonpoint source water pollution control projects. As part of its capitalization grant applications, each state must annually prepare an Intended Use Plan (IUP) that describes the intended uses of the available funds.

The Minnesota Legislature has established the Clean Water Revolving Fund (CWRF) under Minnesota Statutes Section 446A.07 to receive federal capitalization grants and state matching funds. The Minnesota Public Facilities Authority (PFA) is responsible for managing the CWRF and its assets. The PFA is authorized to prepare the annual IUP based on the Project Priority List prepared by the Minnesota Pollution Control Agency (MPCA). The PFA is also responsible for financial administration of the point source (wastewater and stormwater) program through which the PFA purchases the general obligation bonds of local governments to finance eligible projects (transactions which are commonly referred to as loans secured by general obligation system revenue pledges). The PFA's responsibilities include reviewing financing applications, setting the loan rates, along with terms and conditions, determining eligibility for principal forgiveness, and managing the assets of the fund. In addition to preparing the Project Priority List, the MPCA is responsible for reviewing wastewater and stormwater projects to ensure they meet technical and environmental requirements. Nonpoint source loan programs are administered by the MPCA, the Department of Agriculture, and the Department of Employment and Economic Development.

Infrastructure Investment and Jobs Act (IIJA)/Bipartisan Infrastructure Law (BIL)

The Bipartisan Infrastructure Law (BIL) also known as the Infrastructure Investment and Jobs Act (IIJA) was signed into law November 15, 2021 and provides additional federal funds for clean water infrastructure projects through the CWSRF. The IIJA provides funds over a five year period to supplement the CWSRF and provides dedicated funding to address emerging contaminants.

The 2024 CWRF IUP will be used to apply for IIJA Supplemental funds, IIJA Emerging Contaminants (EC) funds and the 2024 base capitalization grant. States must provide a state

match to receive federal base and IIJA supplemental cap grant funds. The IIJA emerging contaminant funds do not require a state match.

The 2024 IUP identifies projects and activities the PFA intends to fund from the Clean Water Revolving Fund in state fiscal year (FY) 2024 (July 1, 2023 to June 30, 2024). To fund these projects and activities, the PFA will use a combination of funds from federal base capitalization grants, IIJA funds, state matching funds, and other fund revenues. Project timing and other constraints will be used to determine the actual source of funding used for each project which will be detailed in the annual clean water report to EPA. The 2024 IUP includes projects to utilize the full amount of estimated 2024 Base and Year 2 IIJA Supplemental Federal capitalization grant funds. Refer to Table 1 summary for estimated IUP totals.

II. Point Source (Wastewater and Stormwater) Program

A. Project Priority List

The Project Priority List (PPL) prepared by the MPCA identifies wastewater and stormwater projects that are potentially eligible to receive CWRF financing over the next five years. Projects are listed in priority order based on a priority point system established by the MPCA in Minnesota Rules parts 7077.0100 to 7077.0121. The FY 2024 PPL contains 300 projects with a total estimated cost of \$3.1 billion and is attached as an Appendix.

MPCA rules governing clean water priority points criteria focus on environmental and public health factors related to water quality and also include climate resiliency. The PPL scoring criteria for NPDES wastewater projects emphasizes age and condition of existing infrastructure, excessive inflow and infiltration (I/I) and repeated failures including by-pass and Sanitary Sewer Overflow (SSO) events. Stormwater project scoring encourages green infrastructure in areas with high impervious surface ratio as a proxy for pollutant loading, volume reduction/infiltration and encouraging multiple environmental benefits. Clean Water projects incorporate the latest design standards (including Ten State Standards), which considers relevant climate information such as the new Federal Flood Risk Management Standard. The facilities planning processes includes a cost and effectiveness project review which considers the potential for efficient water use, reuse, recapture, and conservation, and energy conservation of prospective projects.

B. Placement on the IUP

The Intended Use Plan (IUP) identifies projects on the PPL that are eligible to apply for and receive CWRF loans in FY 2024. The IUP is prepared by the PFA in accordance with Minnesota Statutes Section 446A.07, Subdivision 4 and Minnesota Rules Part 7380.0422. For a project to be placed on the IUP, the PFA must receive a written request signed by an official of the municipality (city, township, county, or district) that will be the borrower for the loan. The request must include a schedule indicating that the applicant expects the project to receive all necessary approvals and proceed to the point of receiving a CWRF loan within approximately one year from the approval

of the 2024 IUP. Applicants seeking construction loans must have received preliminary approval of their wastewater facilities plan or stormwater project plan by the MPCA for their projects to be eligible for placement on the IUP.

Eligibility for placement on the IUP does not guarantee a project will receive a CWRF loan. Minnesota has significant clean water infrastructure needs and the PFA must balance loan demand and lending capacity by setting a fundable range for projects on the current IUP in order to preserve lending capacity for future needs. A municipality with a project in the IUP fundable range must complete the loan application process with the PFA and receive project certification from the MPCA under the provisions of Minnesota Rules part 7077.0281 before a CWRF loan can be approved.

An approved IUP remains effective until the following year's IUP is approved. A project listed in the IUP fundable range that does not receive a loan but submits a loan application to the PFA and is certified by the MPCA by June 30, 2024 will be carried over in the fundable range on the next IUP.

C. Draft IUP, Public Review and Comment

In January 2023, a notice was sent to all municipalities in the state with information about the CWRF program and IIJA funds including instructions on how to request placement on the PPL and IUP. An announcement was also posted on the PFA website, and a GovDelivery notice sent out to interested persons. In addition, PFA and MPCA staff presented information about CWRF Program and the IUP/PPL process at various conferences, workshops and webinars with prospective CWRF participants and other interested parties. Information about the IIJA funding was also provided at these conferences and workshops.

Based on the IUP requests received, a draft 2024 IUP was prepared and presented to the PFA Board on October 9, 2023. The PFA Board approved the fundable range and base interest rate discount for the 2024 IUP (see paragraphs D – IUP Project List and G – Terms and Conditions below) and authorized the draft IUP to be made available for public review and comment. Public comments on the draft 2024 IUP were accepted through November 13, 2023.

On October 13, 2023 the draft 2024 IUP and public notice were posted on the PFA website, and a GovDelivery email was sent out to prospective participants, consulting engineers, local government associations and organizations and interested parties. The notice stated that public comments would be accepted through November 13, 2023. The PFA received 14 comments from local governments or their representatives requesting that projects be added, removed or information updated or corrected on the 2024 IUP. MPCA provided comments identifying facility plan approvals and clarifying project numbers. A table summarizing the comments received and action taken is shown below.

PFA also received a comment letter from the Environmental Defense Fund requesting the CWRF IUP goals be aligned with Minnesota's Climate Action Framework water quality and flood control goals, including investing in natural infrastructure measures. The Environmental Defense Fund also recommended PFA use principal forgiveness funds to address and support natural infrastructure projects. PFA has shared the comments with the MPCA for future discussion on the potential use of CWRF funds for natural infrastructure measures and the role of the CWRF in the Climate Action Framework.

D. IUP Project List

The 2024 IUP project list is shown as Table 1 on pages 16-19 and is divided into two parts.

Table 1, Part A lists carryover projects from prior years' IUPs that submitted loan applications to the PFA and received technical approval and certification from the MPCA by June 30th of the applicable year. Pursuant to Minnesota Rules 7380.0422 subpart 1A, these projects are fundable in FY 2024 and the PFA will award funding when each project completes the application and bidding process. Table 1 lists 42 carryover projects with total requested loans totaling \$203 million in estimated CWRF loans and \$73 million in estimated Principal Forgiveness, WIF and PSIG grants as explained below. CWRF project loan requests in excess of \$51 million will be limited to annual cash flow needs with the final loan amount negotiated each year between the applicant

and PFA staff. In some cases, carryover projects have also tentatively been identified as eligible for additional subsidization or grants as further explained in Sections H, I, and J below.

Table 1, Part B (New Projects) lists 59 new IUP project requests totaling \$368 million in requested loans and other funding. The CWRF has limited lending capacity to meet these needs and the PFA is not able to offer funding to all new project requests. Therefore, the PFA in consultation with the MPCA, has set the 2024 IUP fundable range for new projects at 40 points. Projects with 40 or more points on the 2024 PPL are listed in the fundable range and will be allowed to apply for loans. Decisions about the IUP fundable range are re-evaluated each year. If the fundable range cutoff point is raised next year, only projects qualifying as carryover projects are assured of being listed again as fundable projects. Some Part B projects may also qualify for federal principal forgiveness or WIF grants.

Table 1 also lists 15 project requests that are not being placed on the 2024 IUP at this time. Of these, 3 projects (Belle Plaine, Barnesville, and Litchfield) are not eligible for the IUP at this time because their facility plans or stormwater plans have not received preliminary approval by the MPCA. Three small communities (Silver Lake, Lewisville, and New Auburn) submitted IUP requests and are being referred to USDA Rural Development for possible loan and grant funding through their program; other requests (Jackson, Mahnomen, Menahga, Staples and Perham_02) are ranked below the historic CWRF fundable range; others are outside of the 2024 IUP timeframe (Zimmerman_02, Albert Lea_02, Alexandria Lakes Area Sanitary District and Pequot Lakes_02) or removed because they are not CWRF projects (Sacred Heart and Olivia drinking water treatment plant projects).

E. Possible IUP Amendment

The PFA may consider amending the 2024 IUP during the fiscal year if additional projects on the 2024 IUP meet the requirements and the PFA determines that the CWRF has sufficient funding capacity to offer additional loans in 2024. To be considered for an IUP amendment, a project must: 1) be ranked with at least 40 points on the 2024 PPL; 2) have its wastewater facilities plan or stormwater project plan preliminarily approved by MPCA; 3) have secured any other necessary funding; and 4) show that it will be ready to proceed with construction before the next (2025) IUP is expected to be approved. Applicants that would like their projects to be considered for an IUP amendment are advised to keep their PFA loan officer informed of the status of their project.

F. Loan Application Requirements and Deadlines

All carryover projects in Part A have met the loan application submittal deadlines and have previously submitted plans and specifications to the MPCA. In accordance with Minnesota rules 7380.0425, subpart 1, new Part B projects in the fundable range will have six months from the approval of the IUP to submit a loan application to the PFA and plans and specifications to MPCA. However, projects that want to be ready for construction as soon as possible when funds are available are encouraged to submit a loan application to PFA and plans and specifications by the end of March 2024 to give MPCA and MDH adequate review time to allow project certification

by June 30, 2024.

G. Loan Terms and Conditions

Terms and conditions for CWRF loans are determined pursuant to Minnesota Statutes Section 446A.07 and Minnesota Rules Part 7380.0430. Construction loans are not awarded until as-bid construction costs are submitted to the PFA. CWRF loans will be made at below-market rates in accordance with federal and state law. The basis for setting interest rates is described in Minnesota Rules Part 7380.0442. Interest rates are based on the greater of the current bond market rates for AAA or AA rated municipal bonds as determined by a daily index, (or the bond yield scale of the PFA's bonds if PFA bond proceeds are available) less any applicable discounts described below. The interest charged includes a servicing fee up to 2% of each loan payment. Fee revenues are used to pay program administrative expenses. Fees are non-program income.

For projects that receive loan awards after the 2024 IUP is approved, the PFA has set a base discount of 1.00% that will be applied to the applicable bond yield scale for loans up to \$76 million, with no base discount applied to loan amounts in excess of \$76 million.

Additional discounts up to 2% may be applied to borrowers under 2,500 population as described in Minnesota Rules Part 7380.0442, Subpart 3B (7380.0442 - MN Rules Part). These discounts take project affordability into account. The minimum interest rate under PFA rules is 1 percent.

The standard loan term is 20 years, and can be up to 30 years for those projects that meet the affordability criteria described in Minnesota Statutes Section 446A.07, Subdivision 7. No loan term can exceed the useful life of the project.

In order to manage large project requests within the CWRF annual lending capacity, the PFA may provide separate financing agreements for some projects over more than one year based on the project's cash flow needs as negotiated between PFA and the borrower.

H. Additional Subsidization

The federal capitalization grants require a certain percent of the funds be used for additional subsidization of projects beyond the below-market interest rates on loans described above. The PFA provides additional subsidization to eligible projects in the form of Principal Forgiveness grants, meaning a specific dollar reduction in the amount of loan principal that must be repaid, which is granted at the time a CWRF financing agreement is awarded.

<u>Minnesota Statutes, Section 446A.07</u>, Subdivision 8, authorizes the PFA to provide principal forgiveness to the extent permitted under federal law to address affordability needs and for green infrastructure projects.

The PFA received the 2023 base capitalization grant in September of 2023. The 2023 base grant is \$13,788,000 and requires a minimum of 20% (\$2,757,600) be used for additional subsidization.

The PFA also has \$18,063,383 in additional subsidization funds available from prior federal funds. The IUP Table 1 shows \$15.3 million in estimated carryover projects that are eligible for green project reserve (GPR) or affordability principal forgiveness. New project requests will be reviewed for principal forgiveness affordability after loan applications are submitted.

I. Affordability Criteria

Under section 603 (i)(2) of the Clean Water Act, states may provide additional subsidization to benefit a municipality that meets the state's defined affordability criteria. The PFA has reviewed its affordability criteria as part of the IUP process to ensure that additional subsidization is available to cities with high priority project needs that would otherwise be unaffordable.

PFA defines its affordability criteria for federal CWRF Principal Forgiveness in PFA statutes (MN Statute 446A.072) based on the state Water Infrastructure Fund (WIF) program criteria. WIF is a state grant program that addresses affordability needs for sanitary sewer infrastructure projects. The methodology to calculate WIF grants looks at financial impact on a municipality's users if the municipality had to finance the project with only CWRF loan assistance. Affordability criteria considers the total system cost, including annual operation and maintenance costs, debt service for prior capital improvements and projected new debt service for the proposed project based on the maximum allowable loan term. The cost impact per household is determined by dividing the total system costs by the number of residential users (measured by equivalent residential units) to determine the average cost per household. If the average cost per household exceeds 1.4% of the municipality's median household income (MHI), or the service area MNI, if smaller than the municipality, the proposed project is considered to create significant financial hardship for the municipality.

Principal Forgiveness and/or WIF grants may be granted to a CWRF project if the average annual residential wastewater system cost would otherwise exceed 1.4% of the median household income (MHI) of the project service area. The amount of Principal Forgiveness or WIF grants are limited to 80 percent of the system costs over 1.4% of MHI with a maximum of \$5,000,000 or \$20,000 per connection. The PFA reserves WIF and Principal Forgiveness grants for eligible CWRF projects when they are certified by MPCA in an amount based on the project cost estimate at the time of certification or the as-bid costs, whichever is less.

In addition to income, federal law requires population trends and unemployment data to also be considered in determining projects eligible for principal forgiveness funds that are used to address affordability needs.

Minnesota considers population trends through the Minnesota Pollution Control Agency's calculation of Essential Project Components (EPC) which is used in the WIF program to determine the portion of a project needed to address existing wastewater needs as opposed to growth-related needs. The MPCA is required to calculate the EPC percentage based on the costs necessary to convey or treat the existing wastewater flows and loadings. The EPC percentage thereby limits WIF and Principal Forgiveness awards for communities with growing populations.

The PFA will also consider unemployment data as a secondary factor after the WIF criteria for federal Principal Forgiveness funds. To the extent possible, PFA will direct federal Principal Forgiveness funds to eligible projects whose county unemployment rate is higher than the state's unemployment rate.

Projects qualifying for principal forgiveness or WIF cannot be determined based solely on information provided in the IUP request. Additional project information submitted during the application phase including details on system users and system costs, debt and as-bid costs are necessary to calculate the cost impact to system users, and whether the project triggers the affordability criteria.

J. Green Project Reserve

Federal Principal Forgiveness funds in the base and IIJA supplemental capitalization grants may also be granted to point source projects that address green infrastructure, water or energy efficiency improvements or other environmentally innovative activities, including activities to mitigate stormwater runoff and enhance sustainability per Section 603 (i)(2) of the Clean Water Act. Under Minnesota Statutes, Section 446A.07, Subdivision 8, paragraph (8), the GPR Principal Forgiveness amount is limited to 25 percent of the eligible CWRF project cost as determined by the MPCA, up to a maximum of \$1,000,000. In addition, many of the projects funded through the nonpoint source programs described in Section IV (pp. 9-10) meet the GPR criteria. As in prior years, solicitation for GPR projects was included in the public notice regarding point source project proposals. The GPR solicitation for the 2024 PPL and IUP was sent to all municipalities in January 2023. GPR eligibility cannot be determined based on an IUP request and eligibility will be verified by the MPCA during the plan and specification review process.

K. Use of Principal Forgiveness in FY 2024

The PFA awards federal Additional Subsidization funds in the form of Principal Forgiveness grants to address affordability needs and for GPR eligible point-source projects based on readiness to proceed (starting with carryover projects) and priority order. Except for GPR projects, the source of funding for each project (federal Principal Forgiveness or state WIF funds) will be determined at the time of award. Table 1, Part A, shows the estimated amount of Principal Forgiveness and WIF grants for eligible carryover projects.

One carryover project (Otsego – West WWTP) includes GPR elements and will be awarded principal forgiveness funds when the project proceeds to construction. Nine carryover projects (Zumbro Township, New London, Kandiyohi Co- Glacial Lakes SSWD, Pelican Rapids, Henning Inman Street, Madison, Appleton, Long Prairie and Walker) trigger affordability criteria based on current data and will be awarded principal forgiveness funds or WIF if eligible based on final data. WIF/principal forgiveness funds will be awarded when the projects proceed to construction.

Principal forgiveness funds will be reserved and awarded to eligible projects based on their priority ranking, beginning first with the carryover projects (that received technical approval and

certification in a prior fiscal year), followed by new IUP projects. If sufficient grant funds are not available, a project may remain on the IUP as a carryover project and eligible funding will be reserved and awarded when new appropriations are available.

L. CWRF Federal and State Requirements

CWRF-funded projects are subject to both federal and state requirements. Requirements are detailed in the application materials and in the Contract Packet posted on the PFA website.

The IIJA, signed into law November 15, 2021 (Public Law 117-580), included additional provisions and funding to support the State Revolving Funds (in Minnesota this is the Clean Water Revolving Fund). Build America, Buy America (BABA) Act is a new domestic sourcing requirement for federal financial assistance programs for infrastructure. An earlier EPA approved Adjustment Period Waiver has been amended which places limitations on which projects qualify for the waiver. Consult with your loan officer and MPCA for additional information.

III. **Summary of FY 2023 Point Source Project Activity**

A total of 36 projects on the 2023 PPL totaling \$333 million were funded in FY 2023 through the coordinated efforts of the PFA (through the CWRF, WIF, and Clean Water Legacy Fund programs), and other funding partners.

IV. Nonpoint Source Programs

Since 1996, the PFA has allocated \$93.6 million in CWRF funds for sub-revolving funds within the CWRF for nonpoint source programs that are managed by PFA member agencies. Nonpoint source funds allocations provided \$60.3 million to the Minnesota Department of Agriculture's AgBMP program, \$32 million to the MPCA's Clean Water Partnership Loan Program, and \$750,000 to the Department of Employment and Economic Development's Tourism Loan Program.

A. Agriculture Best Management Practices Loan Program

The Minnesota Department of Agriculture is responsible for administering the CWSRF Agriculture Best Management Practices (AgBMP) Loan Program for Section 319 and 320 nonpoint source projects in accordance with Sec. 17.117 MN Statutes. The AgBMPloan program assists farmers and rural landowners in implementing best management practices (BMPs) eligible under Sections 319 and 320 of the federal Clean Water Act. Allocations of SRF funds are made to counties, soil and water conservation districts, and joint powers organizations for loans to implement local comprehensive water plans, which are a component of Minnesota's Nonpoint Source Management Program (319 plan). Some local projects may also implement components of the Barataria-Terreborne National Estuary Program Comprehensive Management Plan (320 plan). The local units of government approve projects proposed by farmers, rural landowners and agriculture supply businesses that implement priority BMPs to prevent or mitigate nonpoint source pollution to surface or ground waters. Approved projects are then referred to cooperating local financial institutions that provide low interest loans to finance the completed project. Examples of eligible BMPs include animal waste control systems; structural conservation practices such as waterways, erosion and sediment control basins and terraces; repair of failing individual septic systems; and abandoned well sealing.

The Department of Agriculture provides funds at 0% interest to designated local lenders for eligible projects. Applicants must contact their local government to obtain a certification of

project eligibility and then apply to the designated local lender who will evaluate the financial credit worthiness of the project. Local lenders may charge borrowers up to 3% interest and other fees for underwriting the loan.

Since 1996 the PFA has allocated \$61.3 million in CWRF funds to the AgBMP program, which has generated over \$249.5 million in loans. Over the last five years, the average loan repayments received by the programs were \$10.4 million per year which are available to make new loans. In FY 2023, the AgBMP made \$18.2 million in loans. Demand for AgBMP program funds remains very strong.

No new funding allocation is proposed for 2023.

B. Clean Water Partnership Loan Program

The Minnesota Pollution Control Agency is responsible for administering the CWSRF Clean Water Partnership loan program for Section 319 nonpoint source projects in accordance with Sec.
103F.725 MN Statutes. The Clean Water Partnership (CWP) loan program assists local units of government address nonpoint source pollution problems. Loans can be made to counties, cities, watershed districts, and joint powers organizations that have an approved CWP diagnostic study/implementation plan or equivalent report. Loan funds may be used to implement a variety of best management practices (BMPs) such as sedimentation basins and detention ponds, replacement of failing individual sewage treatment systems, lakeshore landscaping for erosion control and stabilization, streambank stabilization, in-stream and in-lake chemical treatment and aeration, forestry and parkland BMPs, and groundwater aquifer recharge area BMPs. The interest rate on CWP loans was changed in 2017 to 0% from 2% in an effort to increase participation. The loan term may vary depending on the project.

Since 1996 the PFA has allocated \$32.1 million in CWRF funds to the CWP loan program, which has generated over \$91.6 million in loans. Loan repayments of approximately \$2.8 million per year return to the program to make new loans. In FY 2023, CWP loans totaled \$3.6 million. Demand for CWP program funds remains strong.

The PFA will allocate an additional \$2,000,000 in state FY 2024 for the CWP loan program.

C. Tourism Loan Program

The Tourism Loan Program is administered by the Department of Employment and Economic Development (DEED) to provide loans to tourism related businesses to improve and replace septic systems. Program funds are used in conjunction loans from private financial institutions. The interest rate on the program funds is 2%. The rate on the bank loan is negotiated between the bank and the borrower. In 1996, the PFA provided an initial \$750,000 to capitalize the program, which has generated over \$1.3 million in loans. All funds have been disbursed and loan repayments continue to be available on a revolving basis. No new loans have been made for several years.

No new funding allocation is proposed for FY 2024.

V. Financial Status of the CWRF

Table 2 (page 20) shows the sources and uses of funds in the CWRF for FY 2023, total amounts from the beginning of the program in FY 1989 through FY 2023, and the estimated amounts for FY 2024.

The PFA has developed a financial model to estimate the average annual lending capacity of the CWRF based on the current assets in the fund. The PFA currently estimates the average CWRF lending capacity to be approximately \$153 million per year in perpetuity, assuming no new state or federal funds are received. In many years, the PFA has used its reserves and bonding authority to make loans at higher levels based on strong demand.

Funding demand has always exceeded annual lending capacity, which the PFA has addressed by establishing a cap on the base interest rate discount and a fundable range for new project requests based on PPL priority points. Demand for CWRF financing continues to grow, and total loan requests for the 2024 IUP are \$577 million, nearly four times the sustainable long-term lending capacity of the CWRF. To maintain balance between current demand and future lending capacity, the PFA in consultation with the MPCA, each year determines a fundable range for new projects on the IUP based on PPL priority points. For new projects on the 2024 IUP, the fundable range cutoff has been set at 40 points.

In approving the 2024 IUP, the PFA commits to providing CWRF loans to all Part A carryover projects and Part B new projects in the fundable range that are able to proceed within the fiscal year.

While the total requested loans exceeds the sustainable lending capacity of the Fund, it is within a manageable level that the Fund can sustain in the short term. In the long term, however, without continued federal and state support for the program, funding beyond the Fund's average lending capacity will decrease its future lending capacity.

VI Federal Funds

Minnesota's 2023 base capitalization grant was \$13,788,000 which was significantly less than prior years due to reductions from Congressionally Designated Spending (CDS) earmarks taken from the SRF program. PFA received the 2023 base cap grant in September 2023 and expects to receive the Year 2 IIJA supplemental cap grant of \$38,311,000 in spring 2024. Congress has not yet appropriated funds for the 2024 base cap grants.

The 2023 Minnesota Legislature appropriated the required matching funds for the 2023 and 2024

base cap grants and Years 1 -3 IIJA supplemental cap grants.

The Year 2 IIJA Emerging Contaminants cap grant, which will be transferred to the Drinking Water Fund, is \$3,909,000 and does not require a state match.

Technical Assistance (TA) Authority/Set-Asides

In addition to financing clean water projects, amendments to the CWA enacted in the IIJA permits states to set-aside a percentage of capitalization grant funds for certain non-project activities. Up to 2% of each capitalization grant can be set-aside for technical assistance for small, rural, and tribal publicly owned treatment works. EPA defines rural, small, and tribal publicly owned treatment works as systems serving populations of 10,000 or less or facilities treating less than 1 MGD.

Two percent of the 2024 Base (amount TBD) IIJA Supplemental Year 2 (\$766,220) and IIJA Emerging Contaminants Year 2 (\$78,180) capitalization grants will be reserved for potential future technical assistance activities to small, rural, and tribal publicly owned treatment works (POTWs). The MPCA will use TA funds from a prior years' cap grant to contract for a provider to deliver technical assistance activities with a focus on asset management (training, inventory of assets, mapping, etc.). MPCA will also use TA funds to pay for staff to work directly with small and rural communities.

Program Administration

The PFA reserves the authority to use up to 4% of the IIJA Year 2 Supplemental cap grant (\$1,532,440) and up to 4% (\$156,360) of the Emerging Contaminants as needed for program administration, including potential additional staff and funds to develop improved online CWRF tools. Emerging contaminant funds are limited to future administrative activities related to emerging contaminants. Any amounts not utilized in 2024 will be reserved for potential future program administrative activities.

Technical assistance activities will be detailed in work plans submitted to EPA with the associated capitalization grant applications. Table 3 contains information on TA and Administrative Costs.

VII Transfers

Federal regulations allow transfers up to 33% of cumulative federal capitalization grants from Clean Water to Drinking Water or vice versa. Per EPA, transfers of EC funds are based on the IIJA drinking water EC cap grant allotments.

Additional time is needed to identify eligible CW emerging contaminant projects, while the Minnesota Department of Health has identified high priority DW emerging contaminant projects on the 2024 IUP. Therefore, the PFA intends to transfer \$3,909,000 from the CW EC capitalization grant to the Drinking Water Fund to help address high priority DW EC projects on the 2024 DW IUP. PFA intends to transfer the \$3,909,000 back to the CW Fund in the future.

A transfer in the amount of \$3,909,000 will be made from the CW Fund Emerging Contaminants

capitalization grant to the Drinking Water Fund for DW Emerging Contaminants projects.

VIII. Goals of the Clean Water Revolving Fund

The member agencies of the PFA are committed to using the Clean Water Revolving Fund as effectively as possible to protect, preserve and improve water resources in the State. The agencies will work to bring together federal, state, local, and private resources to meet these goals.

A. Short Term Goals

- 1. Prepare for a bond sale late calendar year 2023.
- 2. Continue to negotiate loan amounts with applicants funded on an annual cash flow basis in order to meet project needs while limiting the annual impact on the CWRF.
- 3. Continue to promote asset management for CWRF recipients
- 4. Facilitate on-going discussions with AgBMP and CWP staff about nonpoint source program demand, priorities, and available funding.
- 5. Further develop plans to utilize and implement the 2% set-aside for technical assistance activities for small and rural publically owned treatment works.
- 6. Continue to support MPCA efforts to identify clean water emerging contaminants project needs.

B. Long Term Goals

- 1. Help cities implement projects to make their water infrastructure more climate resilient.
- 2. To the maximum extent possible, provide timely funding for all projects that receive technical approval and certification from the MPCA, including projects eligible for principal forgiveness and WIF.
- 3. Utilize the assets of the CWRF so the State employs a balanced approach to protecting and improving Minnesota's waters quality by financing both point source and nonpoint source projects.
- 4. Actively coordinate state and federal agency programs to maximize funding for projects on the Project Priority List, including those that have affordability needs.
- 5. To make funds available to as many high-priority projects as possible while maintaining a steady and sustainable fundable range.
- 6. To administer the CWRF so that its revolving nature is assured in perpetuity.
- 7. To apply a variety of delivery mechanisms to best reach and serve different types of clientele.
- 8. To implement technological solutions to increase efficiencies with program operations.

IX. Cross-Collateralization

As permitted by Congress in legislation approved in 1997, the PFA has cross-collateralized the bonds sold for the Clean Water Revolving Fund and the Drinking Water Revolving Fund. The purpose is to enhance the security of bonds sold for both programs, thereby improving the credit rating and reducing the interest rate on the bonds. This allows the PFA to pass on the best possible interest rates to its borrowers. The revenues from loan repayments in each program are pledged first to the bonds for that program. After the revenues in each program have been used to make the PFA's bond debt service payments and meet all other payment and coverage requirements under the bond resolutions, funds in excess of these requirements may be used to cover a default in the other program.

Given the coverage requirements the PFA must meet for its bonds, the general obligation pledges provided by the borrowers, and the financial management practices of the PFA (as reflected by the AAA rating of its bonds), it is very unlikely that a default would occur. The cross-collateralization of the two programs provides even more assurance to the bondholders and enhances the financial strength of the programs.
