

 CareerForceMN.com will be enhanced to support the job seeker's experience with the CareerForce system






- Part of Systems Integration work funded by MJSP



Primary Themes and Findings:


- 1. Get to the point faster
- 2. Make it easier to read
- 3. Simplify content, presentation
- 4. Engage and guide users






#### Information architecture recommendations

- 1. Prioritize most important content and eliminate the rest
- 2. Mirror the process of the job search
- 3. Quickly guide customers to their best next step
- 4. Use plain language in navigation and labels
- 5. Break down internal silos within the site structure



## Updating MinnesotaWorks.net Zip code assignments

- Ensures Zip codes are assigned to CareerForce locations within the same LWDA
- Ensures Zip codes are assigned to the closest CareerForce location within the LWDA
- Assigns all non-Minnesota Zip codes to CareerForce from anywhere



#### Tell us about your test accounts

- We created the ability to exclude accounts from federal, state, and local reporting
- If you've created a test account for training or any other reason let us know, so we can exclude it from reporting

#### Reporting Exceptions

- Early stages of developing a process for translating CareerForceMN.com content






#### CareerForceMN.com Sprint Review

#### What is a sprint review?

- A demonstration of the work that the product team has completed over a specific period
  - This can include new features, bug fixes, and changes to how the product (in this case, CareerForceMN.com) functions
- A time to ask questions and give feedback to the product team



## What we accomplished

- ✓ Caring Careers call to action ("CTA") added to the homepage, including translations in Spanish and Somali
- ✓ Drupal Security Update to v10.2.3
- $\checkmark$  Added an attribute to identify test and demo accounts
- $\checkmark$  User report fixes to the CSV exports, needed for name split
- $\checkmark$  User report updates so that the report exports matched the report views
- ✓ Detailed what would be needed for the new name fields (First Name, Middle Initial, Last Name, and Preferred Name)

- ✓ Determined what would be needed to move from the single "First Name and Last Name" field to First Name, Middle Initial, Last Name, and Preferred Name fields for the name split (method, file type, collaboration, planning, etc.)
- ✓ Identifying all the places the single "First Name and Last Name" field token is used across the site, for planning
- ✓ Designed the user experience workflow to prompt a user to review and update / verify the name split
- ✓ Created the new name fields (First Name, Middle Initial, Last Name, and Preferred Name) for the name split
- $\checkmark$  Hid the single "First Name and Last Name" field

## Demo: Show and tell

- Updated Account Profile:
  - Includes 4 new fields (First name, MI, Last name, Preferred name)
- New field on "My Profile" excluding testing & demo records from reporting
- Existing Full name field hidden on Account Profile
- Temporary CTA on Homepage for Caring Career Campaign





## Next steps/Project schedule

## Timeline summary

- Noticeable improvements to CareerForceMN.com on a regular basis
- February 2025 Cutover from MinnesotaWorks.net to new site
- Future Continue to make improvements on new site





- Implementing the name split moving from the single "First Name and Last Name" field on CareerForceMN.com to First Name, Middle Initial, Last Name, and Preferred Name fields
- Updating the site to use the new First name field token across site (modals, emails, views, etc.)
- Researching Webform updates to use the new name field tokens, when and where needed (planning and prep)
- Researching Site performance and optimization (site speed)
- Updating the mobile-responsive hamburger menu default to be collapsed (rather than expanded)
- New CareerForceMN.com data access request form
