Kelly Drummer | Executive Director, Migizi

Prior to joining MIGIZI in November 2018, Kelly served as founding President and CEO of the Tiwahe Foundation for seven years, Tiwahe is an American Indian community foundation which focuses on providing micro grants to American Indian communities, strengthening leadership initiatives and network building. During her 20 years of philanthropy and non-profit work, Kelly has worked with the Jewish Community Foundation, The Family Partnership, Headwaters Foundation for Justice, and New Foundations — a Project for Pride in Living program. Kelly currently serves on the Saint Paul Foundation Community Impact Grants Committee, The Family Partnership Board of Directors and other projects that benefit American Indian Woman and youth. She holds a M.A. degree in Philanthropy and Development from St. Mary's University and a B.A. in Cultural Anthropology from the University of



Minnesota. Kelly currently lives in NE Minneapolis with her husband and two children.

Ryan Mulso | Associate Director, LatinoLEAD

Ryan Mulso serves as a crucial link to our membership. He facilitates and coordinates LatinoLEAD's workgroups, action teams and programs. He also leads on developing LatinoLEAD's processes and systems to support members, partners, and volunteers.

Ryan is a second generation Latino and a former educator. He was formerly an outreach director and national training associate for Educators 4 Excellence (E4E). Ryan started working for E4E in 2014 and was instrumental in the nonprofit's growth and program development.

He has experience and success in developing leadership programs at the national level. He built from scratch an online curriculum resource for 35,000 members and 80 staff at E4E. He also hosted training sessions over the past 5 years with nearly one thousand participants. He has skills in leading community outreach initiatives which he did for several years at E4E.




Ryan is a graduate of the University of Wisconsin - River Falls and was a policy fellow at the University of Minnesota's Humphrey School of Public Affairs.

Marcus Owens | Executive Director, African American Leadership Forum

Marcus Owens is the Executive Director of the African American Leadership Forum. At AALF his mission is to improve the economic health of underserved communities in the Twin Cities by creating opportunities through public and private partnerships. Best described as a social entrepreneur, systems shifter and community developer, Owens believes that expanding economic and educational opportunities while improving health and well-being for everyone, is key to building a healthier, equitable community. His work across the Twin Cities is now more essential than ever, following the George Floyd uprising in 2020.

Bo is CAAL's Founder and Executive & Network Director. She is a practice-based possibilian who focuses on creating community-centered, asset-based solutions and transforming practices so that there are meaningful changes for those most impacted by systemic inequities. Having immigrated to the United States as a refugee child after the Secret War in Laos, Bo's lived experiences continuously shape how she creates to ensure communities can fully participate in, contribute to, and shape our democracy. Her extensive leadership experiences include building and leading local, national, and global efforts.

Ahna Minge | Assistant Commissioner for Budget Services and State Budget Director, Minnesota Management and Budget (MMB)

Ahna Minge is Assistant Commissioner for Budget Services and State Budget Director at Minnesota Management and Budget (MMB). Ahna recently returned to MMB after serving as Chief Financial Officer at the Minnesota Department of Human Services. She previously served as a budget team lead and executive budget officer at MMB, where she was part of the division's leadership team and played an integral part in the Governor's budget decisions, including the Health Care Access Fund, provider tax negotiations, and the Gubernatorial transition.

Ahna started her state service in the health economics programs at the Minnesota Department of Health and has previously worked in local government, where she administered major federal grants and performance



management efforts for the City of Minneapolis. She holds a Master of Public Policy degree from the Humphrey School at the University of Minnesota and a Bachelor of Arts degree from Macalester College. Ahna is a past recipient of the Robert M. Armstrong Award from the National Association of State Budget Officers.
