# Minnesota's Partners for Youth Career Pathways Project


Minnesota's Youth-Focused Disability Employment Initiative (MN DEI)

is working to increase the number of youth with disabilities served though Minnesota's youth workforce system. This includes youth who are currently out of school and who may have spent time in foster care, become teen parents, dropped out of school, experienced homelessness, or have been involved with the juvenile justice system.

**Partners for Youth Career Pathways** takes a creative, team approach to helping youth with disabilities ages 14 to 24 prepare for employment. This may include job training, education, employment and benefits planning services, and vocational rehabilitation services. The project is a partnership of workforce, community-based, disability organizations, and Minnesota's Department of Employment and Economic Development (MN DEED). This new way of working together to provide services and supports is available to youth in three select regions of the state. Are you or a young person you know trying to find or stay on a pathway that leads to a successful career?

## **Disability Benefits Counseling**

Access to benefits counseling will help youth and families better understand how work income may impact Social Security benefits (such as SSI) so they can make well-informed choices. More Workforce Centers will become Ticket to Work Employment Networks.

# **Disability Resource Coordinators (DRC)**

Knowledgeable staff will help youth and their teams identify and locate needed resources, accommodations, and supports.

## Integrated Resource Teams (IRT)

IRT teams will be used to coordinate the efforts of workforce, educational, and community-based organizations as they work together to provide needed resources.

# **Specialized Staff Training**

MN DEI will increase the capacity of Minnesota's youth workforce system to serve youth with disabilities, especially those with additional challenges or from diverse cultures.

### **Family-Friendly Information**

Youth and their families will receive helpful information, advocacy and referral through a partnership with PACER Center.



# The Guideposts to Success and Career Pathways

Youth-focused, individualized planning is at the heart of the project.

**The Guideposts for Success** are used by the project to help identify what all youth, including youth with disabilities, need to make the move from school to adulthood successfully. They are rooted in high expectations and the understanding that a youth with a disability is a youth first, and a youth with a disability second. This approach considers the needs of youth in multiple areas: education, career development, adult service systems, youth leadership, and family involvement.

**Career Pathways** are a combination of education and training, employment experiences, and support services that lead to employment in a specific industry or occupation. Through Career Pathways, students gain the knowledge, skills, and credentials needed to find employment and advance in their careers in Minnesota's high demand industries.
