# **Updates- DC Vaubel**

#### Guiding values and guidelines for recommendations (Also located in PowerPoint)

AWWC members discussed the grounding values and guidelines for the recommendations in the report at the last meeting. Support staff reviewed feedback from Committee members on initial draft and offer these as incorporating the additional thoughts and comments provided. There was no additional feedback from Committee members.

- Diversity, inclusion, and equity are essential core values and top priorities of One Minnesota. Recommendations will be framed with an equity lens in recognition that agricultural and food processing workers are essential to Minnesota's economy and their labor puts food on the tables of Minnesotans.
- Recommendations will focus on improving the safety, health, and wellbeing of agricultural and food processing workers.
- Recommendations will remove barriers between agencies and stakeholders, and bring community voices to the table.

#### Timeline

An additional meeting was added on November 15<sup>th</sup> to the timeline. This meeting will give the committee more time discuss the progress of the report and see where things are in terms of consensus. Deputy commissioners Warfa and Vaubel are unable to attend, but Deputy Commissioner Blissenbach will be present.

#### November 10<sup>th</sup> Migrant Services Consortium Meeting

AWWC members are invited to attend the November 10<sup>th</sup> Migrant Services Consortium meeting. Members of the staff will be in attendance to present their recommendations. The Executive Order states that this Committee should consult with the Consortium on a regular basis, and this will be a good chance to keep them in the loop.

#### Committee work past December 1<sup>st</sup>

The deadline for the recommendations is December 1<sup>st</sup>, but the committee will continue to work past the deadline. Deputy Commissioner Vaubel would like to open the discussion on how members would like to move forward in terms of frequency of meetings, topics to work on, and next steps. This will be an ongoing Conversation.

# Work Group Recommendations

At the last meeting, the fist-to-five consensus process was discussed and explained. At this meeting, committee members will have a chance to try it out. This is not a final decision on the recommendations, but it is meant the Committee some idea on where people are and where there might be concerns. Based on feedback from the last meeting, members of the work groups have broken down their recommendations by administrative, legislative, and agency-levels. Committee members will vote on each recommendation individually after each workgroup presents their report. Staff would like to hear from anyone with concerns at the 2 or below level. For rule making and legislative, staff want to know where committee members are using fist-to-five. For agency level recommendations staff would like to know concerns or items that need prioritization. This is an opportunity for the work groups to be able to get feedback and identify what is working, what isn't working, and what suggestions or concerns need to be addressed.
