Meeting Notes

Meeting convenes

Commissioner Jodi Harpstead (Department of Human Services) started the meeting with the
announcement that this meeting is fully virtual because an in-person meeting is not practical or prudent
due to the health pandemic, pursuant with Minnesota Statutes, section 13D.021.

Welcome and updates

- Steve Grove, Commissioner of the Department of Employment and Economic Development, addressed the concern that has been brought up during this Council's journey that it lacks Latinx representation. Due to the legislative mandate that appointed councils can have no more than 15 members, it was not possible to add a Latinx member to this Council. Two prominent leaders of the Latinx community have been invited to be part of the Economic Security Advisory Council. The Co-Chairs and Commissioners will meet with these leaders to get their input and ideas on how to spend the ARPA dollars.
- The first phase of this Council is rapidly coming to a close, and, knowing that this was an imperfect timeline, the Governor's office is most interested in hearing the themes that are rising to the top as most important for ARPA funds.
- The Council was provided a summary of how they ranked the themes and ideas during their prioritization exercise conducted prior to this meeting.
