# Housing Work Group Recommendations Update

The housing Work Group met on Friday to finalize the recommendations, based on feedback received at the last AWWC meeting. Updates to the recommendation included rewording to address the complicated housing issues in MN with a "broader brush" and moving the shortage of housing issue to the recommendation section.

Committee member Emilia brought up that homeownership is an important path to safety, health, and wellbeing for workers, particularly food processing workers who live year-round and currently own mobile homes in mobile parks.

## **AWWC Recommendations Vote**

A majority vote will be taken on the recommendations by the Committee. Members were given the option to vote on each individual recommendation or in categories/themes. The Committee opted to vote by themes. The themes include Communication, Housing, Workplace Safety, and Fair Labor Standards.
