Kom pib ua tsab ntawv thov tshiab, nias "+Get Started (Pib)" nram no. Thaum twg koj rov qab los rau Homepage (Nplooj Pib), koj yuav pom qib kev xa txog txij twg raws li cov kob cim qhia rau nram qab ntawm daim yuaj kev xa.

- Yog tias qhov kob cim qib kev xa yog **BLUE (XIAV)**, ces yog tseem xyuas txog qhov kev xa koj tsab ntawv, thiab tsis tag yuav tau ua dab tsi.
- Yog tias qhov kob cim qib kev xa yog **GREEN (NTSUAB)**, yuav tsum tau ua ib yam rau. Nias rau Submission Card (Yuaj Kev Xa) kom tiav.
- Yog tias qhov kob cim qib kev xa yog **RED (LIAB)**, yog muaj ib qho ua yuam kev lawm. Thov mus cuag tus **Administrator (Neeg Tuav Dej Num)** ntawm txoj kev pab no.

Pom zoo kom siv Chrome mus rau qhov chaw saum huab cua no.

Thov siv lub tshuab computer nkag mus rau qhov chaw saum huab cua thiab cov ntawv thov. Siv tsis tau qhov chaw saum huab hauv lub tshuab nqa ntawm tes.

Rau Cov Neeg Siv Tshiab:

Txoj kev nias rau **Sign Up (Rau Npe Koom)**, yuav qhia kom koj ntaus koj qhov chaw sau ntawv email thiab teeb muaj qhov password (lo lus txuas nkag). Thaum twg koj xai tau koj qhov password (lo lus txuas nkag), yuav teeb tiav koj qhov as khauj thiab koj yuav txuas tau mus rau ntawm qhov chaw saum huab cua.

Rau Cov Neeg Rov Tuaj Siv:

Siv qhov chaw sau ntawv email thiab qhov password (lo lus txuag nkag) uas koj teeb muaj thaum chiv thawj txuas nkag mus rau hauv qhov chaw saum huab. Yog tias koj tsis nco qab koj qhov password (lo lus txuas nkag) lawm, nias "Forgot your password? Tennessen Warning Notice (Tennessen Tsab Ntawv Ceeb Toom): Raws li Minnesota Cov Cai, ntu 13.04, nqe 2, peb thov kom tau cov ntaub ntawv ntawm koj los ntsuas seb koj puas tsim nyog tau kev pab los ntawm Minnesota Department of Employment and Economic Development (Minnesota Tuam Tsev Txhawb Kev Ua Hauj Lwm thiab Tsim Tsa Kev Khwv Noj Khwv Haus) (DEED). Koj tsis tag yuav qhia cov ncauj lus nug txog, tiam sis yog tsis qhia ces yuav ua rau lub tuam tsev tsis muaj peev xwm ntsuas tau koj txoj kev tsim nyog tau kev pab.
