Root Cause Coalition Presentation

Title: Health Equity in Rural Communities – Lessons of COVID-19's Impact on Food System Workers

Overview: The U.S. food production system is increasingly dependent on immigrant and migrant workers to staff everything from food processing plants to farm fields. Minnesota's meat packing plants were among the first COVID "Hot Spots" early in the pandemic. The movement of COVID through rural migrant and immigrant communities shone a light on how social determinants of health like housing and wages create unique barriers to health equity for those who staff our food system. In 2021, Governor Tim Walz signed an executive order creating the Governor's Committee on the Safety, Health and Wellbeing of Agriculture and Food Processing Workers to both support the unique needs of agriculture and food processing workers during the pandemic, and to recommend legislative changes to support their health and safety into the future.
